# 2025 HOME PRODUCTS SHOW EXHIBITOR CONTRACT

January 25<sup>th</sup> & 26<sup>th</sup>, 2025



By signing this contract, the Exhibitor agrees to the following:

A. To abide by all the rules governing the Home Products Show 2025.

B. To make no claim for any reason against the Heart of Texas Builders Association, Heart of Texas Builders Association employees and/or agents. The Heart of Texas Builders Association and the Extraco Events Center will not be liable for the fulfillment of this contract as to delivery of space, and further will not be responsible for delays, damage, loss, increased costs, or other unfavorable conditions due to the following causes: by reason of the building being destroyed by fire, act of God, public enemy, national emergency, strikes, the authority of the law, or any other causes beyond their control. They will, however, in the event of not being able to hold a show for any of the above named reasons, reimburse the Exhibitor pro-rata for any prepaid rent, less any and all legitimate expenses incurred by the Heart of Texas Builders Association and the Extraco Events Center for advertising, salaries, fees, etc.

C. To indemnify Heart Of Texas Builders Association against and hold it harmless from any claims arising out of the acts or negligence of the Exhibitor and their agents or employees.

D. Any matters not specifically covered by the rules and regulations of the Home Products Show 2025 shall be subject solely to the decision of the Heart of Texas Builders Association.

E. CANCELLATION POLICY: The Exhibitor shall give notice of intention, in writing, to cancel or withdraw from the Home Products Show 2025. In the event that notice is received prior to October 20, 2024, 50% of the Total Cost (per booth) of the exhibit space for which the Exhibitor has contracted shall be returned to him. In the event that notice is received on or after October 20, 2024 the Exhibitor shall be obligated for 100% of the total rental cost of the exhibit space in accordance with the terms of the agreement.

F. The Lessor reserves the right to cancel this contract at any time if the Lessee and their agents or employees are conducting or promoting illegal activity on the premises, have been convicted of a felony, have been charged with a criminal indictment, or are conducting or promoting any unsafe activity on the premises. In the event the Lessor cancels this contract, one hundred (100%) percent of the total rental cost for the booth shall be returned to the Lessee.

G. No advertisement can be displayed in the front parking lot. Any advertisement in front has been paid for through sponsorships.
